Online registration begins Tuesday, January 27, 2026.

1. Choose a camp based on the age of your child, or the grade that your child will be entering in the 2026-2027 school year.
2. Online registration is the quickest & easiest way to register your child for summer camps. Registering online provides real-time camp availability, secure online payment, and immediate confirmation of registration, and is accessible 24/7 from any device with internet access.

I understand these risks and assume them knowingly and willingly. My Child and I will take every precaution to safeguard my Child's health, safety, and personal belongings. I agree to instruct my child to obey all rules, regulations, and instructions given by instructors and/or authorized personnel. I further agree that no instructor or other authorized personnel will be held responsible or liable for injuries or other mishaps caused by my child's deliberate disobedience of rules, regulations, or instructions. I understand the Kendall County Forest Preserve District ("KCFPD") cannot eliminate all risks or guarantee my Child's safety.</p>			
<p>3. I understand that state law mandates Program staff report any suspected child abuse or neglect to the appropriate authorities for investigation. General Release: Knowing the risks described above, I agree, on behalf of my Child and my Child's family, heirs, and personal representative(s), to assume all the risks and responsibilities surrounding my Child's participation in the Program.
